



Rules and Regulations

Admission

- 1. All patrons entering the facility without a season pass are required to pay the facility admission fee, including swimmers, non swimmers and spectators.
- 2. Season passes must be picked up each time the holder exits the pool. Passes may not be left at the front counter. Passes not picked up will be forfeited.
- 3. A fee will be charged for a replacement season pass.
- 4. Pool Hours are 12:00pm 8:00pm daily, except in inclement weather.
- 5. The pool closes at 6:00pm for home swim meets.
- 6. No refunds due to inclement weather.
- 7. The pool is closed when the temperature is 70° or below.

Facilities

- 1. Lockers are available for patron's use with their own lock. Items may not be left in the lockers overnight. If this occurs, the lock will be cut and the items will be removed to the office where they can be claimed by the owner. The Borough is not responsible for the cost of replacement of any lock removed after business hours.
- 2. Deck furniture is for the convenience of our patrons. It must remain on the deck and may not be removed by patrons.
- 3. Belongings remaining on chairs, benches, tables or lounges for more than one hour, in an attempt to "save" the furniture is strictly prohibited. Said belongings will be removed to the office.

Safety

- 1. The rules and requests made by lifesaving personnel must always be followed.
- 2. Children under ten (10) years old must be accompanied by a parent or responsible person of at least fifteen (15) years of age at all times. While in the water, the parent or responsible person must remain within arms reach of the child.
- 3. Non-swimmers are not permitted past the bulkhead. On the pavement area, non-swimmers must be under the control of an adult when walking beyond that point.
- 4. Persons who appear to be under the influence of alcohol or narcotics will be denied admission.
- 5. Anyone ten (10) years of age and under must pass a swim test to enter the deep water (beyond the bulkhead). The swimmer will be asked to do the following:
 - a. Swim 1 length of the swimming pool;

b. Tread water for 30 seconds.

Upon passing the swim tests, the swimmer will be awarded a safety bracelet. The swimmer must wear this bracelet at all times while swimming past the bulkhead. A fee will be charged for a replacement bracelet.

- 6. No one should engage the lifeguard in unnecessary conversation.
- 7. Obey the no diving rules as painted on the pool deck. Diving in water less than five feet deep, back dives, somersaults from the side of the pool or any other unsafe activities are not permitted.
- 8. Dangerous practices are prohibited. Patrons must not run on decks; climb, sit or jump from fences; dive in shallow water (less than 9 feet deep); swim in the diving areas; double bounce or crowd diving boards; or dunk, push, pull or unnecessarily splash swimmers.
- 9. One person is allowed on the diving board and slide at a time. For the safety of our patrons, rules for the diving board and slide will be dictated and enforced at the discretion of the management.
- 10. Emergency procedures must be observed. Swimmers must leave the pool area immediately upon the signal or request of the Pool Manager.
- 11. No one over the age of six (6) is permitted to play in the wading area.
- 12. Candy, food or beverages are not allowed except in designated areas provided for eating and drinking. No glass items, chewing gum or smoking is permitted anywhere in the facility. Proper receptacles are to be used for disposal of waste and recycling.
- 13. Toys, flotation devices (water wings), snorkels and masks are permitted only in the wading area of the pool and must be under the direct supervision of an adult. Use of all flotation devices must be approved by the Pool Manager.
- 14. Patrons should use a towel to dry before entering the bathhouse and lobby area.

Hygiene

- 1. Children who are not toilet-trained and less than four years old will be allowed in the pool only if they wear a swimsuit diaper or plastic pants and a swim suit. Cloth or disposable diapers are not accepted. "Little Swimmers" are available for purchase at the front desk.
- 2. Acceptable swim attire must be worn by patrons on the deck and in the water. Patrons with religious concerns regarding modesty may wear clean, covering garments that do not interfere with their safety in the water.
- 3. Animals are not allowed in the building or pool area, with the exception of guide dogs. Guide dogs are allowed on deck, but not in the water.
- 4. All patrons must shower before entering the pool. However, wasting water by playing in the showers is not permitted.

- 8. Persons with open cuts, sores, bandages, colds, coughs or infected eyes are not permitted in the pool.
- 9. Spitting, spouting or nose-blowing in the pool is strictly prohibited.

Conduct

- 1. Improper behavior including stealing, mishandling of property, destruction of public ground and facilities will not be tolerated and will result in police intervention.
- 2. Foul or abusive language will not be accepted and may result in the expulsion and or revocation of the pass.
- 3. Failure to obey the rules of the pool may result in temporary or permanent expulsion from the pool.
- 4. The Manager, Instructors, and Lifeguards shall enforce the pool rules and discipline at all times. The rules are for your safety. Please cooperate fully.
